Wholesale Account Requirements	1) To receive a wholesale discount, we must receive a completed wholesale application and a copy of your 2024 Nurseryman/Florist License 48 hours before you purchase. Failure to do so forfeits a wholesale discount and is a violation of Nursery and Florists Law, Title 22, Chapter 23, Section 22-2312, Idaho code. 2) A copy of Idaho State Tax Commission Seller's Permit is required for tax exempt customers.
Ordering Requirements	-Items must be ordered from the Edwards Wholesale Catalog list provided or they are subject to substitutions based on listed items. -Order in full flats. -Please specify an approximate pick up/ delivery date on order.
Deadlines	Custom Grown Orders receive a 10% discount if order is placed by deadlines below. Orders placed after deadlines will not be discounted. <u>Fall crops – Last Friday in June</u> Pick-up/ Delivery deadline – First Friday in November <u>Easter Lilies – First Friday in February</u> Pick-up/ Delivery deadline – Easter, Sunday, March 31 st , 2024 <u>Poinsettias – Last Friday in October</u> Pickup/Delivery deadline – December 23rd.
Pricing through Retail	Annual plant material purchased from the garden store will continue to be discounted 10% off retail prices.
Pickup and Delivery	<ul style="list-style-type: none"> • All accounts must have an invoice or receipt upon departure. Cash accounts must pay prior to leaving the premises! • To receive discount pricing plant material must be invoiced to or paid for with company funds. • Edwards Wholesale Hours available for pickup – <u>Easter lilies and Poinsettias- 8am to 3pm.</u> <u>Fall crops- 6am to 3pm.</u> • Orders picked up after wholesale hours can be arranged but must be scheduled. • Delivery charges per truck. Boise & Eagle: \$40.00 Meridian, Nampa, Caldwell: \$50.00 Ontario & Mountain Home: \$70.00 *Please make sure a staff member is on site at time of delivery to receive plants and assist with unloading.

PAYMENT:	All sales are cash until credit terms have been established. Payment is due 30 days from the invoice date. A 1.5% per month finance charge will be added to past due accounts. Credit accounts 90 days past due will be sent to a collection agency. Edwards Greenhouse, Inc. reserves the right to pass legal fees and collection costs to the customer as well as the right to establish the venue and jurisdiction for legal action.
CANCELLATIONS:	-Cancellations accepted if material has not been purchased or sown. Otherwise, cancellations are subject to a 100% growing fee of finished product. -Orders over 100 flats or 150 units require a 50% deposit. -Custom orders not picked up by the dates listed above will be charged a \$25 daily care fee.
CLAIMS & WARRANTIES:	All claims on plant material must be made within 3 days of receipt. All orders are subject to prior sales. We cannot be liable for more than the invoiced price, nor can we be liable for product deterioration on hold orders or shortages on custom grown orders due to crop failures. This warranty does not apply to plant material damaged or injured due to the Buyers negligence, improper care, unreasonable use, or abuse.
